

Racing Association Catamaran Events Switzerland Minutes of the Ordinary General Assembly Held on 11 May 2019 at 6 PM in Morges

The General Assembly commences at 18:00 by his secretary Carolina Metaxas. The assembly is counting 19 adult active members. Therefore, it can proceed in accordance with the statutes. Carolina greets and thanks the 9 junior members who are also taking part in the assembly.

1. Nomination of the scrutineers

Basile Wohlers and Benjamin Plojoux volunteer and are unanimously appointed.

2. Approval of the minutes of the 2018 OGA and EGA

The minutes of the 2018 Ordinary General Assembly and Extraordinary General Assembly are unanimously approved.

3. President's and technical consultant's reports for 2018

Brief introduction on what is RACES for the sailors who did not know yet.

We have reached slightly above hundred members in 2019.

There are five sections. Two of them (the Nacra 15 Class Association and the F16 Class Association) are members of Sui Sailing since the beginning of this year.

From this year on, the catamarans that are racing within race have been divided within 3 categories:

- SC1 : ratings ≤ 1.075 (e.g. : F16, F18, etc.)
- SC2: 1.076 ≤ ratings ≤ 1.249 (e.g.: Nacra 15, SL16, etc.)
- SC3: ratings > 1.250 (e.g.: Topaz 14, Tyka, etc.)
- SCF : all flying catamarans

The abbreviation SC is for Small Catamarans. Everything is in function of their ratings so it is crucial to have an up-to-date measurement certificate. If any questions about this subject, do not hesitate to contact Yorick (Yorick.Klipfel@pmi.com).



The aim is to group all the catamarans so that they can race all together.

On the other side, some racing documents available for the clubs have been developed, to facilitate the organization of regattas (rules, courses, ...).

From now on, we will apply more to the letter the measurement rules (verification of the certificate, have the documents in order, ...) not to have conflict situations between the clubs or the competitors.

The 2019 season will be very charged: 5 events for the National Championship, 6 events for the Regional Championship (3 of them are already part of the National one) and many other regattas which are out of the championship.

Next year we are going to try to put the regional regattas modeled on the ACVL ones.

4. Treasurer report for 2018

The association has no debts, the current account is positive with 7'411 CHF. It is way higher than the previous years due to the merge with the AM3.

The majority expenditure (half of them) was for the gauges of the catamarans (amount : CHF 3'980). Some of the costs will be reimbursed by the boat owners.
